## 1 THE FIRM IN GENERAL

**ILCT** was founded by a U.S. attorney, Mr. Charles Warren Kirkwood, as a Registered Ordinary Partnership, in Bangkok, on 4 July 1966 and went through various transformations. In 1998, our Asian offices of the firm comprising Bangkok, Vietnam and Taipei, start practicing in Asia under the name of Russin & Vecchi (R&V).

**ILCT** is the official name of the Bangkok Office. ILCT is the lead office of the multi-domestic law firm, Russin & Vecchi (R&V). ILCT is registered as a Grade “A” Thai Consultant with the Thai Consultant Database Centre, Ministry of Finance, entitling it to bid for government projects.

With over 54-year of history, **ILCT** was one of the pioneering international law offices engaging in the Thai business law practices. We have earned our reputation by consciously practicing in a group format and using personnel of diverse educational and technical backgrounds, most of whom are multilingual (Thai, English, Chinese, Japanese, French, Italian and Spanish), forming teams to deal with each matter by applying diversified expertise. With this method and through our inter-office matrix system, we have developed a unique internationalist approach and able to provide tailored services to a wide cross-section of corporate and individual clients.

## 2 ILCT PRACTICE AREAS

In Thailand, the firm is known as International Legal Counsellors Thailand, or “I L C T”. With 7 resident partners and, as of these writing 16 associate lawyers, plus 22 trained paralegals, most of whom are multilingual, together with other support staff, we are 70 in number. With our over 53-year history, ILCT was one of the pioneer law offices engaging in the business law practice in Thailand. We have earned our reputation by consciously practicing in a group format and using personnel of diverse educational backgrounds to form teams to deal with each matter by applying maximum diversified expertise. By this method and through our inter-office matrix system, we have developed an internationalist approach and, indeed, the overwhelming majority of our clients have an international connection, whether by their make-up or by the type of transactions in which they are engaged.

We are a full-service law firm. Among the types of matters handled by our lawyers in Bangkok are the following:

### 2.1 BANKING AND FINANCE

Work in this field includes advising banks, finance companies, insurance companies, etc. on finance institution laws and regulations, often in connection with structuring innovative financing products. We have helped structure new forms of loan, equity and quasi-equity transactions. Our expertise covers the drafting or reviewing of both local and international loan transactions, including loan syndications, structuring and implementing various forms of security for credit extended, as well as creating financing and securitization instruments. We have dealt with loan work out situations. We have worked with more than 75 foreign financial institutions with regard to their interests in Thailand, in one form or another. We have also served as lawyers for the borrowers from time to time.

Our opinion and assistance are also sought on the regulatory and compliance aspects. We review and revise operation manuals for clients.

We assisted with the Thai legal aspects of the global mergers of the Bank of Tokyo-Mitsubishi Bank and of the Chemical Bank-Chase Manhattan Bank, N.A.

### 2.2 COMPETITION/ ANTI-TRUST/ANTI-MONOPOLIES

Work in this field involves advising both domestic and international clients on the extent and impact of the provisions of the Trade Competition Law and associated regulations and rules. The areas covered are improper collaboration amongst competitors (cartels), price-fixing, market abuse by market dominant operators, competition law controls on mergers and acquisitions of companies in Thailand.

Clients that we have advised in relation to competition law include those involved in the retail and hypermarket, tobacco, food manufacturing and distribution, pharmaceutical, motor vehicle manufacturers and energy and mineral resources industries.

## **2.3 CONTRACT NEGOTIATIONS**

We assist clients in negotiating and drafting contracts of every type in Thai and English, including contracts with state parties and joint ventures.

## **2.4 CORPORATE**

Services in this field include the incorporation, maintenance, restructuring, dissolution and liquidation of companies and partnerships. They also include corporate restructuring (increasing and reducing capital, etc.), converting private companies into public companies and getting them listed on the stock exchange, mergers and acquisitions, etc.

## **2.5 CORPORATE RECOVERY SERVICES**

We assist creditors and debtors in debt restructuring and court-supervised re-organization. We represented a group of petrochemical companies in a US\$ 5 billion debt re-organization under, the highest debt re-organization in Thailand.

Our trademark team regularly provides assistance to domestic and overseas brand owners in obtaining the optimum advantages on trademarks in Thailand and internationally. In addition, we have been entrusted to manage and maintain trademark portfolios of many reputable brand owners for many consecutive years.

## ***Patents:***
